Monthly Reports

Regional EMS Steering Committee Report: No meeting

Fire Company: David Fink reported there are legislative changes pending to the small games of chance license and discussion on fire tax will be under old business. Jay Scheffler reported the fire fighters finished class on propane emergencies.

Director of Office Operations: Forrest Wessner III reported the number of zoning and building permits issued are up from last year. The Permit Manager software has been upgraded with some new features.

Director of Parks and Recreation: Forrest Wessner III reported on the recreation commission. They will go ahead with making the soccer field. The recreation commission is in need of topsoil.

Director of Public Works: David Fink commented on a bridge on Buckery Road needs maintenance; he proposes to request the engineer look at the bridge and come back with options to repair this bridge. Roy Stewart said he will request Ryan at Keystone Engineers to look at the bridge.

Road Superintendent: Kevin Huber reported they have done grading, ultra bond on dirt roads, and paved three roads. On Werleys Corner Road they will be replacing double pipes with a box culvert. Next month they will be oil and chipping. David Fink requested Kevin check into Penn DOT signs corrected for Werleys Corner Road; a road closed sign is missing and a cross hatch sign on Route 100 should be removed.

Township Administrator: Janice Bortz reported she opened and closed township building for a zoning hearing appeal, and attended the Penn DOT HOP Occupancy Seminar at the Lehigh Valley Planning Commission, scheduled audit (June 5th) for the EIT office. She met with Jim Kampstra about pension audit, and had the pension audit which is not quite done. Delaware Valley Health Insurance Trust had a workshop that she attended. The bid placements were done, newsletter complete and should be mailed by next week.

Township Zoning Officer: Roy Stewart gave a report on permits and one violation letter was written.

Township Engineer: A letter was sent to Sid German pertaining to a ditch on his property. He addressed the Board of Supervisors comments on the Fenstermacher Road project and he will forward to David Masters.

Environmental Advisory Council Report: Janice Bortz reported for the EAC that Trisha Bankowski is the recipient of the \$100.00 scholarship from the EAC that will be given at the school next week.

Old Business

Fire Tax: David Fink gave an overview of the previous discussion on fire tax and requested Atty. Strohl give an update. Atty. Strohl referenced the second class township code; the implementation of tax would be Real Estate Tax, could be done by resolution (advertise 3 consecutive weeks) according to the local tax enabling law. The appropriation of the tax could be used for purchasing, maintaining equipment, training, and minimal portion for salaries. The fire company would be required to report an annual report to the township. An ordinance could be done to create rules and regulations governing the fire company. David Fink will meet with the financial secretary and look at some accounts. Paul Grothouse commented he would recommend the millage be set to support the fire company long term. Phyllis Breininger questioned if the fire tax received discount and penalty dates and who would collect the delinquent fire tax

Resident Carl Breininger commented that there is a resolution to amend the law pertaining to the small games of chance license.

New Business

Tough Mudder representatives to address Board about June 1st & 2nd event and request specific road closures: David Jaindl addressed the Board of Supervisors about the location of the event. Jon Barker, general manager of Tough Mudder commented that this event is a challenge not a competition and is approximately 10 to 12 miles of obstacles. Bruce Anderson, Pidcock Eng., presented the traffic plant for this event. Portions of Scheirers Road in Heidelberg Township will be closed. All participants, spectators, volunteers will park behind the Weis on Route 100 and be bussed to the site. The only parking on site will be VIP and emergency personnel. Fire Chief Jay Scheffler questioned if there would be radio communication with the emergency personnel within the location? Jon Barker stated a command post will be inside with radio contact. Jay Scheffler commented Miracle League is designated site for Medevac landing, Cetronia will be taking care of ambulance service, and Germansville Fire Company will only be on site at the fire pit.
