Tara Jones is also working on the 2014 Heidelberg Township Newsletter and has contacted 43 organizations requesting article contributions. Janice Meyers requested that any article contributions are needed and due by August 4, 2014. Janice Meyers is working with Roy Stewart on zoning/enforcement issues.

Township Zoning Officer: Ryan Christman presented the zoning officer report to the Board.

Township Engineer: Ryan Christman reviewed the engineer's report with the Board. Ryan Christman presented the two bids for the Buckery Road Bridge repair and the two bids for the Mantz Road Bridge scour repair. For the Buckery Road Bridge repair, Professional Construction Contractors, Inc. from Easton has a bid of \$35,580.00 and Minichi Contracting from Dupont has a bid of \$43,000.00. For the Mantz Road Bridge scour repair, NuPump Construction from New Jersey has a bid of \$18,950.00 and Minichi Contracting from Dupont has a bid of \$21,000.00. Motion by Steve Bachman, seconded by Rodney Schlauch Jr. to accept the bids of \$35,580.00 from Professional Construction Contractors, Inc. for the Buckery Road Bridge repair and \$18,950.00 from NuPump Construction for the Mantz Road Bridge scour repair. Motion carried. Ryan Christman will work with Kevin Huber in contacting the approved companies.

Environmental Advisory Council Report: No report was given.

Old Business:

Vacation of sections of Werleys Corner Road: Ryan Christman will work with Atty. Chuck Waters regarding the wording of the ordinance. Ryan will add the property owner Diane Klase who was not listed on the KCE letter dated 7/14/14.

Special Event/Amusement Tax Ordinance: Motion by Steve Bachman, seconded by Rodney Schlauch Jr. to table the discussion until next month's meeting. Motion Carried.

Proposed parking ordinance: Atty. Keith Strohl reported that he researched everything he could about permissible vehicles and number of allowable vehicles. He noted that campers, boats and commercial vehicles are not allowed only passenger vehicles. Atty. Keith Strohl kept the provision in about abandoned vehicles and also added provisions about an enforcement officer. Atty. Keith Strohl would like Ryan Christman to identify the streets and affected distances by latitude and longitude. Kevin Huber will work with Ryan Christman regarding identifying the streets. This will be discussed at the next meeting.

Lynn Township's proposed ordinances: Janice Meyers reported that the AQC ordinance was adopted and the Weiss Road rezoning was tabled. The Board agreed with the planning commission comments already sent to Lynn Township.

New Business

Request regarding township history area: Phyllis Breininger and Carol Betz reported on their intent to display historical pictures around the board room and hallway area. Carol Betz asked the Board of Supervisors about putting the historical postcards for sale on the Heidelberg Township website. There are 5 different postcards at \$2.50/pack. Janice Meyers reported that Phyllis Breininger and Carol Betz requested \$100.00 in funds to pay for frames. Motion by Steve Bachman, seconded by Rodney Schlauch Jr. to approve this historical project and issue a check for \$100.00 for picture frames. Motion carried. The receipts will be given to Janice Meyers.

Fire Company letter – district boundary change: Motion by Steve Bachman, seconded by Rodney Schlauch Jr. to approve the redistricting letter. Motion carried.

<u>Public Comment:</u> Resident Paul Grothouse had questions/comments regarding recycling. He said Waste Management will not accept single stream recycling from commercial customers. Steve Bachman said the recycling ordinance should be reviewed and Berger Sanitation called about pricing for commercial recycling. Resident Charlie Perich commented on the fire company not having an account. Janice Meyers said the fire tax bank account was opened before any tax money was received. She will check on the exact date.
